**Attention Owners / Exhibitors of Foreign Registered Dogs**

If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC), please review the eligibility requirements in The Rules Applying to Dog Shows, Chapter 11 Section 1. The dog show rules are posted on the AKC Web site at:

<http://images.akc.org/pdf/rulebooks/RREGS3.pdf>. Most important to note are the following:

1. Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred by Exhibitor class.
2. Dogs are eligible to compete in AKC events using the foreign registration for a period of 30 days. That 30-day period begins with the date of first exhibit, regardless of whether the dog earned any points or awards. To continue to compete in AKC events beyond the initial 30-day period, the dog must be either individually AKC registered or by the date of the event, have been granted an extension to exhibit using the foreign registration. The owner or agent can request an extension using the form found on the AKC Web site at: <http://images.akc.org/pdf/extenap.pdf>.

**DIRECTIONS TO SHOW SITE**

**From I-76** – Take Rt 3 (Wooster Pike) north about 5 miles to 162. Take LEFT onto Rt. 162. Second intersection on Rt. 162 is Lake Rd- 4-way stop – take Left. MKC building is approximately 1 mile south on the right.

**From I-71** – Exit at Rt 18 and go west on Rt 18 approximately 1 mile – turn left onto River Styx Road (light) and go approximately 2.5 miles to Rt 162 (Sharon Copley Rd- stop sign) turn right and go approximately 3 miles – road will “T” at a round-about at Wooster Pike. Take 2nd exit off round-about onto Wooster Pike. and proceed approximately ½ mile to light at Rt.162 – take RIGHT on Rt. 162. Second intersection on Rt. 162 is Lake Rd- 4-way stop – take Left. MKC building is approximately 1 mile south on the right.

## **SHOW REGULATIONS**

**ENTRIES CLOSE AT THE SHOW SECRETARY'S OFFICE**, by 6:00pm, Wednesday, April 16, 2025, after which time entries cannot be accepted, altered, canceled, or substituted. Make check payable to MAC Dog Shows LLC. Canadian exhibitors must have fees payable in US Funds.

**RETURNED CHECKS** do not constitute a valid entry fee. The Show Secretary will add a collection fee to the amount of **\$40 to each returned check**.

**ENTRY FORM MUST BE SIGNED** by the owner or the owner's duly authorized agent, otherwise the entry cannot be accepted. Telegraph or telephone entries cannot be accepted.

**OVERNIGHT deliveries** requiring **NO** signature only. Entries not on official AKC entry forms or photocopies of entry forms without the Agreement & Rules on the reverse side of the official AKC Entry Form are **NOT ACCEPTABLE**.

**An AKC Recording Fee of \$0.50 first entry only and an AKC Event Service Fee of \$3.00 for first entry and \$3.50 for each additional entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3.50 will be required for each first entry and \$3.50 for each additional entry in any Licensed or Member Club Rally Trial. An AKC Event Service Fee of \$2.00 per entry will be required for each dog entered at any Open Show.** All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions) these Fees are to be collected by the show giving Club & paid to the AKC. (AKC Rule, Chapter 11, Section 2).

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competing by action of the Trial Committee.

**DOGS MAY ARRIVE** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused. All dogs present must be held on leash in hand except when being judged.

**NO ENTRY FEES WILL BE RETURNED** if the show cannot open or be completed by reason of riots, civil disturbances, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the management.

**OWNERS ARE RESPONSIBLE** for errors in making out entry forms, whoever may make such errors, & no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. PLEASE TYPE OR PRINT carefully, the information on entry forms to eliminate errors. **NO ENTRY SHALL BE MADE** & no entry shall be accepted which specifies any conditions as to its acceptance.

The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The show giving club has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**DOGS NOT REQUIRED FOR FURTHER JUDGING** will be excused.

**ALL AWARDS MUST BE CLAIMED** at the Show, or they become the property of The German Shepherd Club of Northern Ohio, Inc. None will be mailed.

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e., Cocker Spaniel (solid color black, ASCOB, parti-color). Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.). Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles & Ruby, Blenheim & Prince Charles), Poodles (toy, miniature, standard).

The following categories of dogs may be entered & shown in Best of Breed competition; Dogs that are Champions of Record & dogs which, according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

(Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rule, refer to Chapter 11, Section 3).

Mixed Breed dogs entering classes for Agility, Obedience, & Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire & Dam information shall remain blank for mixed breed entrants.
