The first place winners in non-regular classes which have been undefeated in any other class, will be eligible for Best of Breed Competition. Veterans and any other single dog entry class spayed and neutered dogs may compete.

## NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES AFTERNOON SHOW ONLY

**Stud Dog Class** ~ For Stud dogs and not less than two of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their get. Get must be entered in a regular or non-regular class at this show. The decision in the Stud Dog Class shall be based on the merits of the Get. None of those making up the entry judged first in this class will be eligible to compete in Best of Breed by virtue of having won this class.

**Brood Bitch Class** ~ Same as Stud Dog Class except substitute Brood Bitch for Stud Dog and Produce for Get.

### BEST OF BREED

To be followed by Select Dog, Select Bitch, and Awards of Merit  
Best from the Regular Puppy Classes, Best from the Bred-By Exhibitor Classes,  
and Best from the Veterans Classes.

**BEST OF BREED COMPETITION** ~ The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record and Dogs which according to their owners' records have completed the requirements for a championship, but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owners' records. If at the end of the 90-day period the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC.

**AWARDS OF MERIT** ~ The judge may, at his/her discretion, present one Award of Merit for every 10 entries (up to 4) in the Best of Breed competition. The Award of Merit may not be awarded to exhibitors who have already been awarded Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog or Select Bitch; therefore, are already recognized. The Award of Merit is reserved for those quality animals the judge feels are worthy of final consideration for Best of Breed.

**The Club and its Show Secretary** caution all persons entering the show site and show grounds against all hazards which may exist, including, but not limited to: Condition of the site/grounds, parking/loading/ unloading areas, entrances, floors and stairways, elevators and escalators, floor coverings, walkways, tenting/canopies, electrical appliances, cords and fittings, exercise pens, and the presence of animals. All persons should take into consideration this is a sporting event and dress, act and exercise caution appropriate for the activity involved. All persons entering the show, the grounds, site and show areas for whatever purpose do so entirely at their own risk. By virtue of entering the show, the entrant has indicated their acceptance of the terms listed in this premium list and assumes all risks involved.

**PUBLICATION RIGHTS:** By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

### PUPPY SWEEPSTAKES

The Sweepstakes is open to all Borzois who are 6 months of age and under 24 months of age at the time of the Regional Specialty. All dogs entered in a Sweepstakes class, must also be entered in a Regular Class or for Best of Breed Competition at this Regional Specialty, at the regular entry fee. Entry fee for Puppy Sweepstakes is \$15.00.

The Veteran Sweepstakes is open to all Salukis who are 7 years of age or older on the day of the show. Dogs entered in Veterans Sweepstakes Class need not be entered in a Regular class. Neutered dogs and spayed bitches may be entered in Veteran Sweepstakes. Indicate Veteran Sweepstakes and age division on the entry form under "Additional Classes." Entry fee for Veteran Sweepstakes is \$15.00

### JUNIOR SHOWMANSHIP REGULATIONS

**Entry fees are \$10 for Junior Showmanship as a second entry for the dog and FREE as a Junior Showmanship entry only.**

### JUNIOR SHOWMANSHIP

**NOVICE CLASS:** This class shall be for boys and girls who are at least 9 years and under 18 years old on the day of the show and who, at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

**OPEN CLASS:** This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**MASTER CLASS:** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

**NOTICE:** Junior Handlers must include their **AKC JUNIOR HANDLER NUMBER** on each entry.

You may obtain your junior identification number by calling the AKC at 919-233-9767.

**BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on both sides of the entry form.**

Junior Handlers who win a third Novice Class with competition present or a first place in Novice without competition leading to a Best Junior award with competition, would count as one win towards moving to Open, after the closing of entries for a show, **ARE REQUIRED TO TRANSFER** their entry from the Novice Class to the Open Class. **MUST NOTIFY THE SHOW SECRETARY** at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

If the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, **provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five-point major, in the region in which the event is held.** No major for Reserve Winners shall be given based upon an award of Best of Winners.

(There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.)**

**No Entry** shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

**Entry Fees** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the event, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the event before completion, no refund of entry fee will be made. **An Administrative Fee of \$2.00 will be withheld** from all refunds for entries cancelled prior to the closing of entries. **Errors on Entry Blanks.** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

**Each Owner and Agent** listed on the entry form and/or individual responsible for the dog at a show is bound by the Certification and Agreement on the front and back of the entry form regardless of who may have completed & submitted the entry form.

**As specified in Chapter 12, Section 4** of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

**Dogs May Arrive** any time prior to their scheduled time of judging. **Dogs not required for further judging will be excused. Judges Will Not Wait for Any Dog holding Up a Class.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

**All Dogs Present** must be held on leash or confined to their crates except when being judged or when in the exercising ring. **Class Cash Prizes** will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Superintendent's Office advised at once. The Superintendents and show-giving Club disclaim any liability for cash prizes after the judging of the breed is over. **No gasoline or diesel generators** are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

**NOTE:** This club accepts entries for AKC events in accordance with the latest Agreement, entry form instructions and Rules Applying to Dog Shows (rules) of the American Kennel Club. From time to time these are subject to change. In the event of a discrepancy in these entry form instructions, Agreement and rules versus the text within the entry form you sign and submit, the AKC Agreement, entry form instructions and rules in effect at the time these entries close will take precedence.
