**From West**: Take I-76 East to the Bailey Road exit. Turn South (right) onto Bailey Road. Follow Bailey Road to Mahoning Avenue (approximately ¼ mile). Turn West (right) onto Mahoning Avenue. Trial site is about one mile on right hand just past the blue water tower.

**From East**: Take I-80 West which will merge with I-76 West. Proceed two miles after the merger to the Bailey Road exit. Turn South (left) onto Bailey Road. Follow Bailey Road to Mahoning Avenue (approximately ¼ mile). Turn West (right) onto Mahoning Avenue. The trial site is about one mile on the right-hand side just past the blue water tower.

**From Ohio Turnpike:** Take the Turnpike to Exit 218. At the exit, follow signs to Mahoning Avenue. Proceed to Mahoning Avenue West. At the light (Route 45), continue on Mahoning Avenue, crossing over Bailey Road. Trial site is located on the right-hand side just past the blue water tower.

 $\mathbf{OR} \sim \sim$  at Exit 218, take I-76 West (Akron) to Bailey Road. Turn South (left) onto Bailey Road. Follow Bailey Road to Mahoning Avenue (approximately ¼ mile). - 3. CRATES may be left over night; however, YABTC assumes no responsibility for lost or stolen articles. NO dogs may be left overnight!!
- NO X-PENS ALLOWED ~ All crates must have covers/lids that are made for the crate.
- 5. Masks are optional. Judges may choose to wear a mask while in the ring.
- 6. **BE READY** ~ Please have your dog ready at ringside when Steward calls on you.
- 7. BREAKS ~ Our judges may take a break at his/her discretion.
- 8. Judges are not required to wait for dogs.
- 9. Judges will adhere as closely as possible to the printed judging times.
- 10. Feel free to bring pop-ups/tents for shade to crate your dog(s) in your car or in the grass. Feel free to bring a generator if you need to use a fan.
- 11. Bring your own chair. No chairs will be supplied by YABTC.
- 12. NO CRATE SET-UP ON THURSDAY.
- 13. PLEASE PICK-UP AFTER YOUR DOG. POTTY AREAS ~ ALL the grass areas that surround the building.
- 14. YABTC has the right to cancel these trials at any time. If the trial is cancelled, & you have already entered, your check will be shredded.
- 15. If the State of Ohio, Gov. Mike DeWine, or the AKC make changes according to COVID-19, we will abide by the Governor and/or the AKC changes.
