### NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

**Brace Class** ~ No charge if both dogs are entered in a regular class. Otherwise, \$35.00. both dogs must have at least one owner in common.

### BEST OF BREED

To be followed by Select Dog, Select Bitch, and Awards of Merit  
Best from the Regular Puppy Classes, Best from the Bred-By Exhibitor Classes,  
and Best from the Veterans Classes.

**BEST OF BREED COMPETITION** ~ The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record and Dogs which according to their owners' records have completed the requirements for a championship, but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owners' records. If at the end of the 90-day period the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC.

**AWARDS OF MERIT** ~ The judge may, at his/her discretion, present one Award of Merit for every 10 entries (up to 4) in the Best of Breed competition. The Award of Merit may not be awarded to exhibitors who have already been awarded Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog or Select Bitch; therefore, are already recognized. The Award of Merit is reserved for those quality animals the judge feels are worthy of final consideration for Best of Breed.

**The Club and its Show Secretary** caution all persons entering the show site and show grounds against all hazards which may exist, including, but not limited to: Condition of the site/grounds, parking/loading/ unloading areas, entrances, floors and stairways, elevators and escalators, floor coverings, walkways, tenting/canopies, electrical appliances, cords and fittings, exercise pens, and the presence of animals. All persons should take into consideration this is a sporting event and dress, act and exercise caution appropriate for the activity involved. All persons entering the show, the grounds, site and show areas for whatever purpose do so entirely at their own risk. By virtue of entering the show, the entrant has indicated their acceptance of the terms listed in this premium list and assumes all risks involved.

**PUBLICATION RIGHTS:** By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

**Entry fees are \$10 for Junior Showmanship as a second entry for the dog and FREE as a Junior Showmanship entry only.**

**NOVICE JUNIOR CLASS:** For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**NOVICE INTERMEDIATE CLASS:** For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**NOVICE SENIOR CLASS:** For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN JUNIOR CLASS:** For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN INTERMEDIATE CLASS:** For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN SENIOR CLASS:** For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

Junior Handlers who win a third Novice Class with competition present or a first place in Novice without competition leading to a Best Junior award with competition, would count as one win towards moving to Open, after the closing of entries for a show, **ARE REQUIRED TO TRANSFER** their entry from the Novice Class to the Open Class. **MUST NOTIFY THE SHOW SECRETARY** at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

## RESERVE POINTS AVAILABLE

If the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, **provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five-point major, in the region in which the event is held.** No major for Reserve Winners shall be given based upon an award of Best of Winners.

## NOTICE TO EXHIBITORS

**Telephone and Unsigned Entries Cannot Be Accepted. Entries Not On Official AKC Entry Forms, Downloaded and/or Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.**

**Non-Sufficient Funds** ~ if a check has been processed by this Club and/or their Show Secretary and are advised that there are no funds to cover the check received for entries in the exhibitor/owner/handler's account, the Club and/or Show Secretary will charge the exhibitor/owner/handler \$25 to cover their bank fees for the insufficient funds declaration.

**An AKC Recording Fee of \$.50 first entry only and an AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3.50 will be required for each first entry and \$3.00 for each additional entry in any Licensed or Member Club Rally Trial. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.)**

**No Entry** shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

**Entry Fees** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the event, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the event before completion, no refund of entry fee will be made. Claims for prize money must be made in the ring before the judging of that breed is over, and the Superintendent's Office advised at once. The Superintendents and show-giving Club disclaim any liability for cash prizes after the judging of the breed is over. **No gasoline or diesel generators** are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

**NOTE:** This club accepts entries for AKC events in accordance with the latest Agreement, entry form instructions and Rules Applying to Dog Shows (rules) of the American Kennel Club. From time to time these are subject to change.
