- ~ Entries will be accepted in the order they are received.
- ~ **ONLINE PAYMENTS** WILL BE ACCEPTED ~ payment can be made thru PayPal (**Treasurer@yabtc.com**). Please include a \$4.00 convenience fee per event number / per dog to your total; once you receive your PayPal receipt, include that with your entry form(s) & send an email to Mary (**MACDogShows@outlook.com**) or fax to her at 330-599-7185. Include AKC registration number on your PayPal payment so she knows what dog(s) this is payment for.
- ~ **ONLINE ENTRIES** can be made at <https://www.macdogshows.com/online-entries>. You will be asked if you will be paying by check, PayPal (see above), or wish for a STRIPE invoice to be sent to you. If you pay through STRIPE or PayPal, a \$4.00 convenience fee will be charged per event number / per dog.
- ~ **NOTE:** If you pay via STRIPE or PayPal and you withdraw your entry prior to the closing date, you will receive a refund of your entry fee except for the convenience fee(s).

## TRIAL REGULATIONS

**ENTRIES CLOSE AT THE TRIAL SECRETARY'S OFFICE**, by 6:00 pm, Wednesday, October 9, 2024, after which time entries cannot be accepted, canceled, altered, or substituted. Make check payable to YABTC. Canadian exhibitors must have fees payable in US Funds.

**RETURNED CHECKS** do not constitute a valid entry fee. The Trial Secretary will add a collection fee to the amount of each returned check.

**ENTRY FORM MUST BE SIGNED** by the owner or the owner's duly authorized agent, otherwise the entry cannot be accepted. Telegraph or telephone entries cannot be accepted.

**OVERNIGHT DELIVERIES** requiring **NO SIGNATURE** only. Entries not on official AKC entry forms or photocopies of entry forms without the Agreement & Rules on the reverse side of the official AKC Entry Form are NOT ACCEPTABLE.

**A RECORDING FEE OF \$ .50** is to be collected **on the first entry only for each dog, each day**. An Event Service fee of **\$3.00** will be required for each regular class each dog is entered at any Licensed or Member Club Show, Obedience Trial, Rally Trial, or Tracking Test. These fees are to be collected by the show giving Club & paid to the American Kennel Club. (AKC Rule, Chapter 11, Section 2).

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian/the Judge, or barred from competing by action of the Trial Committee.

**DOGS MAY ARRIVE ANY TIME PRIOR** to their scheduled time of judging. Dogs not required for further judging will be excused. All dogs present must be held on leash in hand except when being judged.

**NO ENTRY FEES WILL BE RETURNED** if the show cannot open or be completed by reason of riots, civil disturbances, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the management.

**OWNERS ARE RESPONSIBLE** for errors in making out entry forms, whoever may make such errors, & no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. PLEASE TYPE OR PRINT carefully, the information on entry forms to eliminate errors.

**NO ENTRY SHALL BE MADE** & no entry shall be accepted which specifies any conditions as to its acceptance.

**NO REFUND ON DUPLICATE ENTRIES**. Every effort will be made to find duplicate entries, but if an entry has been processed, no refund will be made.

**BITCHES WHO COME IN SEASON** after the closing date may have their entry fees refunded less \$5.00 per entry upon written certification by a Veterinarian. Notification must be made to the Trial Secretary no later than 10:00am the day of the Trial.

**WHEN THE SAME DOG IS ENTERED** in more than one class, only the highest score will be used for the top awards in Trial or top awards of a breed.

**DOGS NOT REQUIRED FOR FURTHER JUDGING** will be excused. Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The trial-giving club has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**ALL AWARDS MUST BE CLAIMED** at the Trial or they become the property of YABTC. No awards will be mailed.

**ALL DOGS PRESENT MUST BE HELD ON LEASH** or confined to their crates except when being judged or when in the exercise ring. **All handlers are asked to clean up after their own dog.**

## **\*\*\*\* DIRECTIONS TO SHOW SITE \*\*\*\***

**From West:** Take I-76 East to the Bailey Road exit. Turn South (right) onto Bailey Road. Follow Bailey Road to Mahoning Avenue (approximately ¼ mile). Turn West (right) onto Mahoning Avenue. Trial site is about one mile on right hand just past the blue water tower.

**From East:** Take I-80 West which will merge with I-76 West. Proceed two miles after the merger to the Bailey Road exit. Turn South (left) onto Bailey Road. Follow Bailey Road to Mahoning Avenue (approximately ¼ mile). Turn West (right) onto Mahoning Avenue. Trial site is about one mile on the right hand side just past the blue water tower.

**From Ohio Turnpike:** Take the Turnpike to Exit 218. At the exit, follow signs to Mahoning Avenue. Proceed to Mahoning Avenue West. At the light (Route 45), continue on Mahoning Avenue crossing over Bailey Road. Trial site is located on the right hand side just past the blue water tower.
